Division Descriptions:

'A' Division - Considered the advanced division. Players ranked/rated 4 or 5 generally play in this division. Play can be, and generally is, competitive and hard-running. Players ranked/rated 3 do play in this division, though it can be a bit intimidating.

'B' Division - Considered the more relaxed division. New players (1's) and players ranked/rated 2 or 3 generally play this division, though a lot of 4 ranked/rated players like to play this division as mentors and/or ringers.

Player Preference:

List your preference as to whom you feel you absolutely must play with. This often is your wife or husband or companion. Listing more than one preference really throws a wrench in the works during the drafting process, however. If player x requests player y, and player y requests player x, it is an automatic that they play together. However, player x requesting player y, player y requesting player z, etc, gets too complicated and is next to impossible to accommodate.
